

Troesh Matching Gift Fundraising Campaign



July 19, 2018

In early 2016, the RMC Research & Education Foundation received a major gift pledge of \$3M from the Troesh Family Foundation, with a matching requirement and challenge to the industry. The requirement is that the Troesh pledge be matched on a 3:1 basis. In other words, the Foundation needs to raise \$9M over the next five years to take full advantage of the \$3M Troesh gift. If we are successful in reaching our goal, this will be the Foundation's LAST major fundraising campaign, as the endowment will be fully funded at current spending levels including the Founda-

tion's support of the MIT Concrete Sustainability Hub.

All contributions to the RMC Research & Education Foundation are fully tax deductible and pledges can be made over time, but are recognized in full at the time they are made. Most companies and individuals have made five-year pledges. However, we are happy to work with donors to create payment schedules that meet their needs and preferences.
